Sub: Grant/approval of the request for financial assistance for construction of the Building for Industrial Training Institute at Bhadisar, District Chittorgarh.

Dear Sir,

On 20TH March, 2008 we received a written request from you on behalf of the Student Relief Society for the grant of financial assistance for the construction of the building for the Industrial Training Institute (ITI) at Bhadisar in Chittorgarh District, Rajasthan.

I am pleased to inform you that in the meeting of the executive committee of Rajendra and Ursula Joshi Educational Society, Jaipur, your request was considered and it has been resolved that a financial grant of Rs.500,000/-(Rupees Five Lacs Only) be provided to the Student Relief Society for the specific purpose of construction of the proposed building for the Industrial Training Institute at Bhadisar in Chittorgarh District, Rajasthan.

This grant/financial assistance to your society shall be subject to the following terms and conditions.

 This is a onetime lump sum grant/financial assistance and this grant shall in no way create any right, interest or claim for any further grant or financial assistance in future for whatsoever purpose.



- 2. The amount of grant/financial assistance shall strictly be used solely for the purpose of construction of the building for the proposed Industrial Training Institute at Bhadisar in Chittorgarh District, Rajasthan.
- 3. If the full amount of the grant/financial assistance is not utilized in the construction of the building within a period of two years from the date of the disbursal of the grant then the remaining amount shall be returned/refunded by the Student Relief Society to the Rajendra and Ursula Joshi Educational Society, Jaipur.
- 4. Starting from the date of disbursal of the grant/financial assistance, at the expiry of every three months, a complete report along with the photographs of the construction works at the site, shall be submitted to the Rajendra and Ursula Joshi Educational Society, Jaipur. The report shall clearly mention the construction works which have been completed as well as the proposed works to be taken up during the next quarter.
- 5. At the end of each financial year the complete audited financial statements of the Student Relief Society, certified by a Chartered Accountant, showing the utilization of the grant/financial assistance amount in the construction of the building of ITI shall be submitted to the Rajendra and Ursula Joshi Educational Society, Jaipur.
- 6. On the complete/full utilization of the grant/financial assistance in the construction of the building, a Utilization Certificate mentioning the

detailed statement of such use, shall be submitted to the Rajendra and Ursula Joshi Educational Society, Jaipur.

- 7. Rajendra and Ursula Joshi Educational Society, Jaipur shall in the future at all times be entitled to temporarily use and occupy the said building of the ITI along with all the equipment and facilities available in the institute, free of any charge, for any/all of its activities being conducted in Chittorgarh District, Rajasthan.
- 8. Rajendra and Ursula Joshi Educational Society, Jaipur shall in the future at all times be entitled to call for and receive from the Student Relief Society any/all the data and information pertaining to the ITI such asthe number of students/trainees pursuing the vocational courses, number and nature of courses being offered, information regarding the placement of the students/trainees etc. Apart from the foregoing the Rajendra and Ursula Joshi Educational Society, Jaipur shall also be entitled to ask for and receive any data, material and statistical information available with the Student relief society regarding the vocational courses being offered or such similar courses.
- 9. Non-compliance of any of the abovementioned terms and conditions or/and misuse or diversion of the amount of the grant/financial assistance for any purpose other than the construction of the building for ITI, shall result into cancellation of this grant and in such case the Student Relief Society shall be liable to immediately refund the full grant/financial assistance amount of Rs.500,000/- (Rupees Five Lacs Only) to the Rajendra and Ursula Joshi Educational Society, Jaipur.

A cheque dated 25/03/2008 bearing no. 018490 of the Bank of India, branch New Sanganer Road, Jaipur, for the amount of Rs.500,000/-(Rupees Five Lacs Only) is being forwarded along with this letter. Kindly send us a written confirmation of the acceptance of all the terms and conditions contained in this letter as also the receipt for the cheque of the grant/financial assistance. Without prejudice to the foregoing, the encashment of the cheque by the Student Relief Society shall purport to be an unqualified acceptance of all the terms and conditions contained herein, by the Student Relief Society.

We sincerely hope that this little contribution from our Society shall help you in fulfilling and achieving your benevolent and philanthropic cause. We also hope that in future both these societies could have continued association and exchange which in the long run would not only prove to be mutually beneficial and enriching but also fruitful in achieving their respective aims and goals.
